## Strategy

Olive Grove Charter School's (OGCS) major priority areas include: conditions of learning; student outcomes; and engagement. OGCS's LCAP reflects our strategy for using federal funds to supplement and enhance our local priorities funded with state funds in the following specific actions: technology (goal 1, action #4); students with disabilities (goal 2, action #5); professional development and coaching (goal 2, action #6); family communication and involvement (goal 3, action #4). These actions where federal funds will be used focus on four main topics:

1. Access to technology - To maintain 1:1 student access to Chromebooks, to continue to provide hotspots (portable Internet access) to eligible students, and to maintain appropriate and adequate technology for staff and use in the learning center in order to deliver high quality instruction and services;

2. Increasing academic success for students with disabilities - To optimally address individualized needs as identified in students' IEPs, general education teachers, case managers, and SPED support providers will function as a team to plan and implement appropriate adaptations, modifications, and/or accommodations to instruction; reteaching and socialemotional supports will be provided, and research-based academic interventions will be utilized and guided by data driven goals generated via intermittent reviews of progress and benchmark assessment data;

3. Professional development in order to enhance educator equity for our low-income and minority students - To ensure we employ and retain qualified staff in every classification and to ensure teachers are fully credentialed and appropriately assigned, per independent study guidelines;

4. Increasing parent/guardian input in decision-making and participation in programs for unduplicated pupils - Designate a parent liaison (Family Support Coordinator) to manage and coordinate communications with parents, to conduct surveys, to connect families to community resources, and to communicate with families in Spanish.

OGCS implements a meaningful engagement process which solicits input from multiple educational partner groups. OGCS takes a year-round, team-focused approach to monitoring our LCAP metrics and the implementation of actions in order to inform decision making around the use of state and federal funds.

### Alignment

OGCS utilizes a cycle of continuous improvement to align the use of federal funds with actions and services funded by state and local funds as well as across different federal programs. Educational partners work together to determine the schoolwide goals, and student achievement data determines the types of activities that should be provided to increase student achievement. Analyses of student group data inform the educational partners in determining the effectiveness of actions and services and in deciding which activities need to be expanded, changed or replaced.

OGCS recognizes the importance of supporting the professional growth needs of all team members. Through consultation with team members, parents/guardians, community partners, and leadership as well as analysis of student and teacher related data, resources, training, and professional development opportunities aligned with the Local Control Accountability Plan (LCAP) are provided.

As part of ongoing continuous improvement, OGCS ensures these opportunities increase student achievement consistent with the challenging state academic standards, improves the quality and effectiveness of OGCS professionals, develops leadership throughout OGCS, and provides greater access to effective counselors, leaders, paraprofessionals, and teachers.

All OGCS team members have the opportunity to participate in local, regional, statewide, and national conferences, workshops, and trainings. Whenever possible, local, state, and federal funding is leveraged to support professional growth. The expectation is for an OGCS team member to grow professionally and upon return from the conference or training, share the learned expertise with all OGCS team members. OGCS team members are either offered the opportunity or share opportunities with OGCS leadership of upcoming conferences and trainings. OGCS also provides in-house trainings and resources disseminated organization-wide while also building capacity by empowering learning center leadership to facilitate training specific to its center. OGCS has a professional learning plan that annually provides both in-house and local, statewide and national workshop and conference experiences, synchronous and asynchronous training tools, and best practices for online learning as part of its cycle of ongoing continuous improvement for leaders, teachers, and support services team members. Professional learning (PL) opportunities are coordinated with other OGCS programs, actions, services, or strategies to support LCAP goals and outcomes for student success.

PL under Title II is designed to coordinate with multiple strategies, programs, and activities identified in the LCAP, such as:

- PL to develop research-based instructional practices that support all students, including underperforming student groups, to maintain/strengthen California Assessment of Student Performance and Progress (CAASPP) achievement;
- PL to effectively implement and carry out intervention programs;
- PL to cover best practices, integration, core interventions and strategies, and personalization for EL/MLL students;
- PL to support effective implementation of special education services;

opportunities, and PL opportunities are sought out and offered to team members by the leadership team. The Advisory Council discusses academic performance, provides input on the school program and supplemental services to make improvements using Title funds as part of their LCAP conversations.

Teachers and staff discuss the effectiveness of professional learning as part of the school culture and evaluate it taking into account the needs of the school based on student achievement data including CAASPP, ELPAC, benchmark assessments, cumulative assessments, attendance, and student demographic data.
