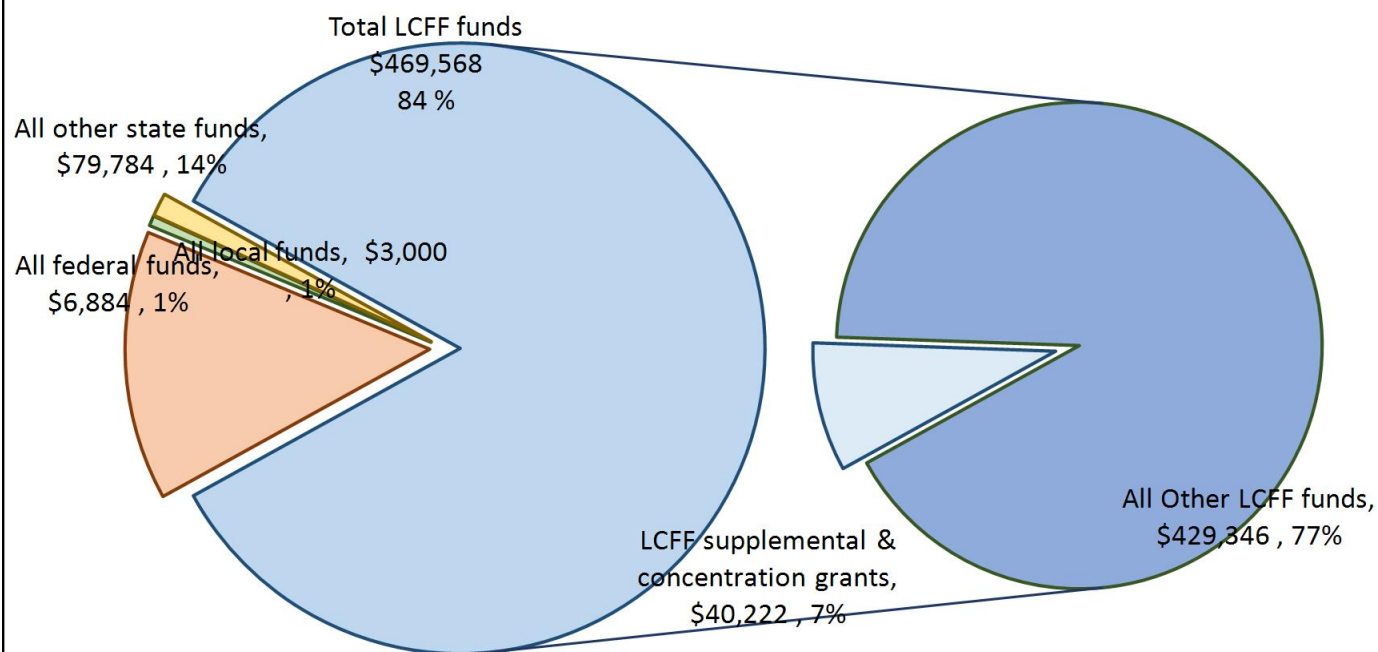

School districts receive funding from different sources: state funds under the Local Control Funding Formula (LCFF), other state funds, local funds, and federal funds. LCFF funds include a base level of funding for all LEAs and extra funding - called "supplemental and concentration" grants - to LEAs based on the enrollment of high needs students (foster youth, English learners, and low-income students).

Projected Revenue by Fund Source

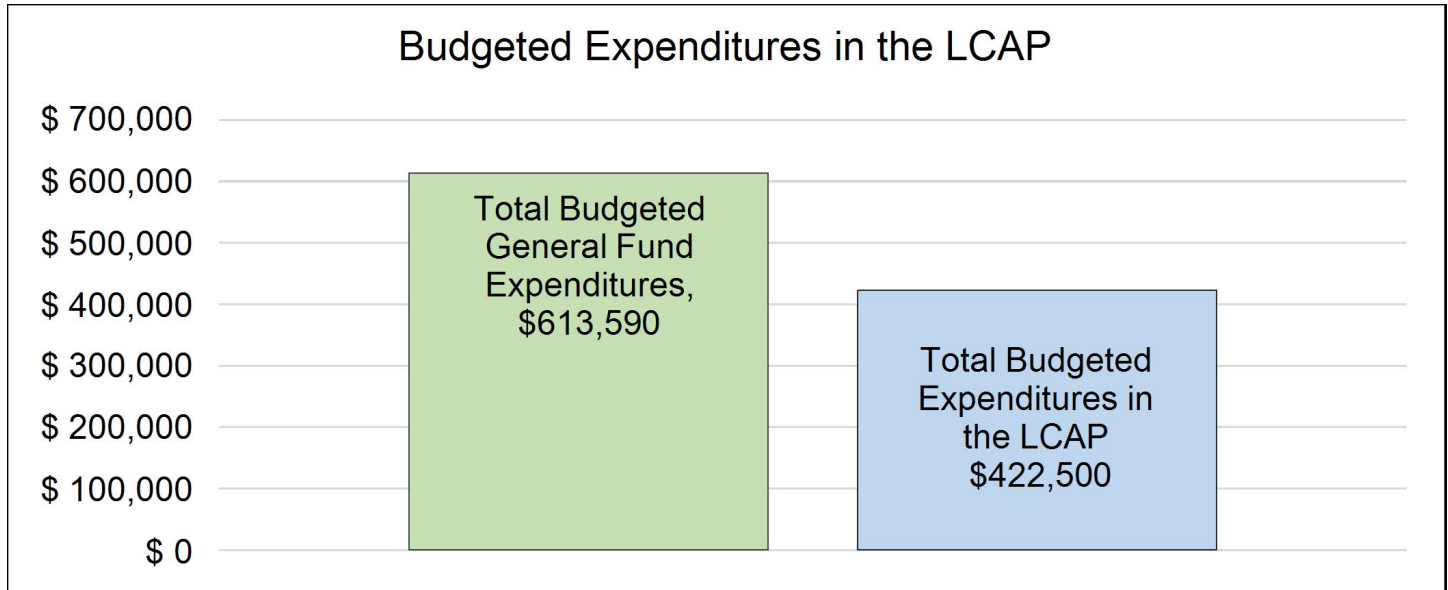


This chart shows the total general purpose revenue Olive Grove Charter School - Buellton expects to receive in the coming year from all sources.

The text description for the above chart is as follows: The total revenue projected for Olive Grove Charter School - Buellton is \$559,236, of which \$469,568 is Local Control Funding Formula (LCFF), \$79,784 is other state funds, \$3,000 is local funds, and \$6,884 is federal funds. Of the \$469,568 in LCFF Funds, \$40,222 is generated based on the enrollment of high needs students (foster youth, English learner, and low-income students).

The LCFF gives school districts more flexibility in deciding how to use state funds. In exchange, school districts must work with parents, educators, students, and the community to develop a Local Control and Accountability Plan (LCAP) that shows how they will use these funds to serve students.



This chart provides a quick summary of how much Olive Grove Charter School - Buellton plans to spend for 2024-25. It shows how much of the total is tied to planned actions and services in the LCAP.

The text description of the above chart is as follows: Olive Grove Charter School - Buellton plans to spend \$613,590 for the 2024-25 school year. Of that amount, \$422,500 is tied to actions/services in the LCAP and \$191,090 is not included in the LCAP. The budgeted expenditures that are not included in the LCAP will be used for the following:

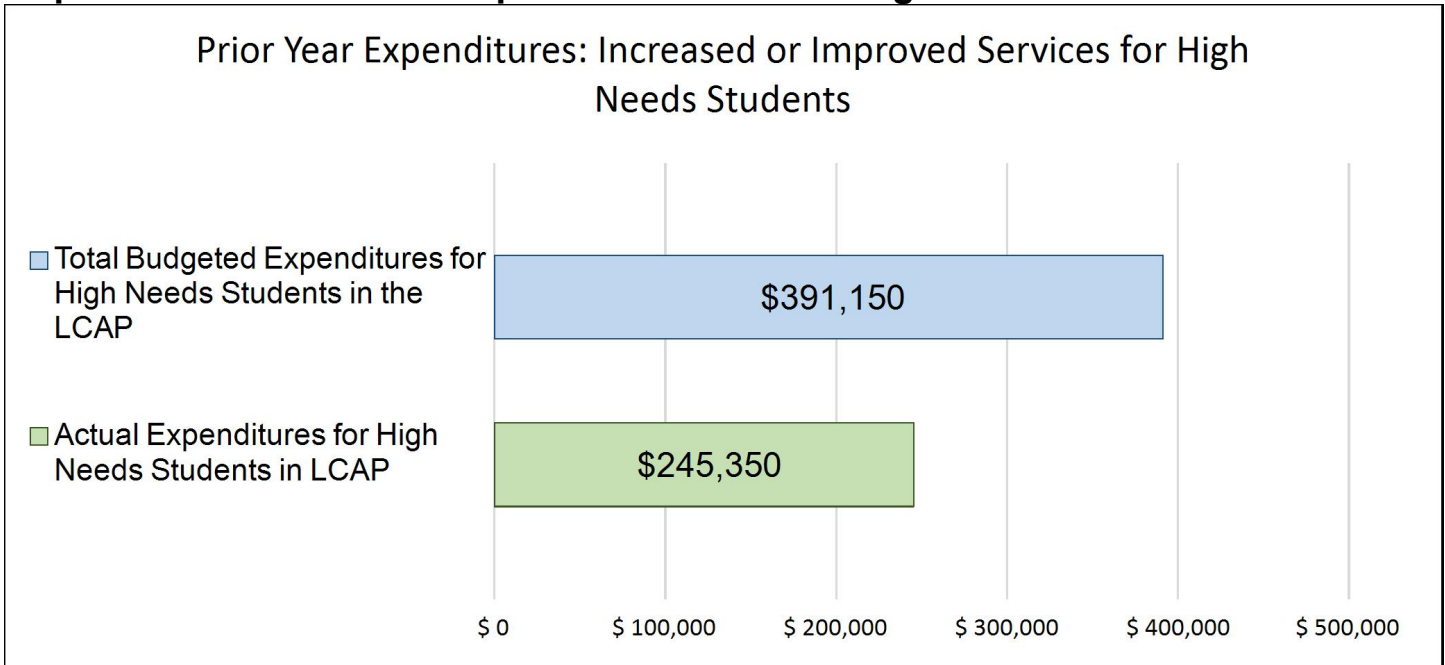

Increased or Improved Services for High Needs Students in the LCAP for the 2024-25 School Year

In 2024-25, Olive Grove Charter School - Buellton is projecting it will receive \$402,222 based on the enrollment of foster youth, English learner, and low-income students. Olive Grove Charter School - Buellton must describe how it intends to increase or improve services for high needs students in the LCAP. Olive Grove Charter School - Buellton plans to spend \$288,000 towards meeting this requirement, as described in the LCAP.

Update on Increased or Improved Services for High Needs Students in 2023-24



This chart compares what Olive Grove Charter School - Buellton budgeted last year in the LCAP for actions and services that contribute to increasing or improving services for high needs students with what Olive Grove Charter School - Buellton estimates it has spent on actions and services that contribute to increasing or improving services for high needs students in the current year.

The text description of the above chart is as follows: In 2023-24, Olive Grove Charter School - Buellton's LCAP budgeted \$391,150 for planned actions to increase or improve services for high needs students. Olive Grove Charter School - Buellton actually spent \$245,350 for actions to increase or improve services for high needs students in 2023-24.

The difference between the budgeted and actual expenditures of \$-145,800 had the following impact on Olive Grove Charter School - Buellton's ability to increase or improve services for high needs students:

OGCS Buellton exceeded its supplemental and concentration grant allocation but did not spend its entire planned budget for high need students due to the fact that enrollment was lower than anticipated. Therefore both revenue and spending came in below estimates. This difference did not significantly impact the actions and services and the overall increased or improved services for high needs students in 2023-24.
