## **Comprehensive School Safety Plan Overview and Purpose**

California Education Code sections 32280-32289 outline the requirements for all California public schools operating a kindergarten and grades 1 to 12 inclusive, to develop a comprehensive school safety plan addressing the safety concerns relevant to the needs and resources of the particular school.

Comprehensive School Safety Plans are required to contain the following elements:

- An assessment of the current status of school crime at the schools and at school-related functions
- Child abuse reporting
- Disaster procedures, routine and emergency plans, and crisis response
- Suspension/expulsion policies and procedures
- Procedures to notify teachers of dangerous pupils
- Discrimination and harassment policies
- Schoolwide dress code
- Procedures for safe ingress and egress
- Policies enacted to maintain a safe and orderly environment
- Rules and procedures on school discipline
- Procedures for tactical response to criminal incidents
- Protocols for responding to a potential opioid overdose
- Protocols and procedures for responding to dangerous, violent, or unlawful activity
- Instructional Continuity Plan

This Comprehensive School Safety Plan will be reviewed, updated, and adopted by March 1st every year. Annually, the school will report on the status of its school safety plan including a description of its key elements in the annual school accountability report card.

An updated file of all non-sensitive safety-related plans and materials is available for review at each Olive Grove Charter Schools, Inc. learning center and office location.
